#### PERSONS AND ORGANIZATIONS CONTACTED WITH DATES AND EXPLANATIONS OF HOW CONTACTED:

The required Community Meeting was held on Monday, November 4<sup>th</sup>, 2019, a representative of the Petitioner mailed a written notice of the date, time and location of the Community Meeting to the individuals and organizations set out on **Exhibit A** by depositing the Community Meeting Notice in the U.S. mail on 10/23/2019. ## SUMMARY OF ISSUES DISCUSSED AT MEETING:

## I. <u>Overview of Petitioner's Presentation.</u>

## Introduction and Overview of Development Plan.

Bridget Grant opened the meeting and welcomed those in attendance. Ms. Grant introduced the development team and reviewed the conditional rezoning schedule.

Bridget Grant reviewed the site plan and location and explained that the proposed plan includes a reservation for the future Silver Line extension as well as an optional provision for height. It is anticipated that the newly constructed building will have structured parking with office uses above. The Petitioner will also provide streetscape improvements along Bryant Street and S. Summit Avenue adjacent to the site.

The meeting was then opened for questions.

## II. <u>Summary of Questions/Comments and Responses:</u>

It was asked if there was a flood study done and if the building will be out of the floodplain. The Petitioner explained that a flood study will be completed for this project and that all occupiable space will be above the floodplain.

It was then asked if marketing had begun for potential tenants. The Petitioner is still early in the development process and a tenant has yet to be identified.

Ms. Grant thanked everyone for their attendance and the meeting was adjourned.
