Mr. Fields opened the presentation with a description of the site and the proposed development as well as an overview of the rezoning process. There were many questions and comments about the site plan. In general the proposed redevelopment of the site was viewed as a positive in that it will clean up the current property, result in a new attractive building, and most importantly provide a connection between Drexel Place and Heather Lane. This connection would allow traffic from Drexel Place to access the signal at Park Road and Heather Place.
