The required Community Meeting was held on Thursday, January 2, 2020, a representative of the Petitioner mailed a written notice of the date, time and location of the Community Meeting to the individuals and organizations set out on <u>Exhibit A</u> by depositing the Community Meeting Notice in the U.S. mail on 12/20/2019. SUMMARY OF ISSUES DISCUSSED AT MEETING:

I. <u>Overview of Petitioner's Presentation.</u>

Introduction and Overview of Development Plan.

Keith MacVean opened the meeting and welcomed everyone in attendance. Mr. MacVean reviewed the rezoning site plan that proposes to adaptively reuse the existing building with uses allowed by the current zoning on the property. The rezoning request will provide additional flexibility in the type of uses that may utilize the existing building.

The meeting was then opened for questions.

II. <u>Summary of Questions/Comments and Responses:</u>

It was asked if the building would have one or two uses. Mr. Britton explained that there is the potential for one or two uses within the building, but any modification to the existing storefront would remain within the existing building openings.

It was then asked if the alley was going to be used in any way. The Petitioner does not have control of the alleyway, so any use of the alley has to be coordinated with the City and the other property owners that abut the public alley. The property line abuts the alley.

The attendee inquired if the Petitioner had plans to acquire more buildings in the area. Mr. Purcell explained that a large-scale aggregation is unlikely to happen.

Mr. MacVean thanked everyone in attendance and the meeting was adjourned.
