



## Restrictive Zoning / Development Conditions: A) Restrictions for Building Design:

- 1. 100' maximum building height.
- 2. Floor Area Ratio (FAR) of 2.0\*

\*Note: Floor Area Ratio may be applied to the entire combination of parcels shown or any division thereof based on existing or reconfigured lot lines; provided however, the Ownersof the parcels shall be entitled to build up to the maximum 2.0 FAR on their respective parcels.

## B) Restrictions for Use

- 1. The following uses shall be eliminated from the list of those allowed under Chapter 9: General Districts, Part 8.5 MIXED USE DEVELOPMENT DISTRICT; uses permitted by right, of the City of Charlotte Zoning Ordinance:
  - a. Amusement, commercial, outdoor.
  - b. Auction sales excluding automobiles, trucks, trailers and construction equipment.
  - c. Automobile service stations, including minor adjustments, repairs and lubrication.
  - d. Off-street parking as a principal use providing for the public parking, private parking (parking in conjunction with and to serve other permitted uses is allowed).
  - e. Pest control and disinfecting services.
  - f. Exterminators
  - g. Embalming and crematories.
  - h. Gunsmiths
  - i. Building material sales (wholesale and retail).
