Bobby Carver and Reynolds Allen of Edens and Avant represented the Petitioner at the community meeting. Walter Fields and Laura Simmons of Kimley-Horn and Associates also attended the meeting on behalf of the Petitioner.

Mr. Fields explained the overall request which is to modify the existing CC (Commercial Center) site plan by altering the building placement and configuration without adding any additional square footage to the neighborhood center. The site plan changes being requested are designed to make the center more attractive to potential tenants and prevent additional tenant loss. Meeting attendees had several questions and concerns about traffic in the area but the general consensus was that the proposed site plan reconfiguration would be positive and would not have any additional impact on traffic than the current zoning.
