COMMUNITY MEETING REPORT

Petitioner: Faison-Hollow, LLC Rezoning Petition No. 2007-114

Property: Redevelopment of 33.70 acres located at the intersection of Quail Wood Drive

and Quail Forest Drive for high quality residential community

This Community Meeting Report is being filed with the Office of the City Clerk and the Charlotte-Mecklenburg Planning Commission pursuant to the provisions of the City of Charlotte Zoning Ordinance. This matter relates to the redevelopment of the over 30 year old apartments located on the site into a high quality residential community consisting of custom and semi-custom built townhomes and condominiums. As reflected below the Petitioner is pleased with reaction of a number of nearby residents to its redevelopment plans that will replace the existing rental apartments that have exceeded their useful life.

<u>PERSONS AND ORGANIZATIONS CONTACTED WITH DATES AND EXPLANATIONS OF HOW CONTACTED:</u>

A representative of the Petitioner mailed a written notice of the date, time and location of the Community Meeting to the individuals and organizations set out on Exhibit A attached hereto by depositing the Community Meeting Notice in the U.S. mail on August 3, 2007. A copy of the written notice is attached hereto as Exhibit B.

DATES, TIMES AND LOCATIONS OF MEETINGS:

The Community Meeting was held on Tuesday, August 21, 2007 at 7:00 p.m. at the Reformed Theological Seminary, Chapel Building A, 2101 Carmel Road, Charlotte, NC. In addition, Faison held several other meetings prior to filing this petition with residents and leaders of the Rockbridge neighborhood that borders the rezoning site.

PERSONS IN ATTENANCE AT MEETINGS:

Please see the attached sign-in sheet for the formal meeting required by the Ordinance which is attached as <u>Exhibit C</u>. We do note that in part because of significant outreach by Faison with nearby residents, no one attended the public forum held on Monday, August 13, 2007.

SUMMARY OF ISSUES DISCUSSED:

Neil Kapadia of Faison & Associates provided an overview/introduction of the redevelopment plans and the quality of the proposed residential community. Mr. Kapadia then introduced Jeff Brown who reviewed the conditional rezoning process and important dates. Mr. Kapadia reviewed, among matters, that the proposed plan calls for slightly fewer homes than the existing units on the property, the nature of the buffer treatment along portions of the project edge and the conceptual architectural approach to the community.

QUESTIONS & COMMENTS FROM THOSE IN ATTENDNACE:

Comments and questions were raised generally as follows:

• The phasing of the project will likely start with a model home closer to Carmel Road but the precise approach to the build-out has not been finalized. There will be some spec buildings as part of the development and marketing of the project.

- The nature of MX-2 zoning was discussed and it was made clear that the current plan does not contemplate any retail uses.
- There will be an HOA who will govern the community upon completions to ensure long term quality.
- In response to a question about any negative feedback, Mr. Kapadia explained that the reaction has been positive, partly as a result of the outreach to nearby residents and because of the quality of the development replacing the existing apartments that have seen their better day.
- There will be significant grading as is the nature of projects of this kind but an effort will be made to save certain trees along the perimeter of the property.
- Given that security associated with the existing apartments has been a concern, efforts will be made to deal with security during demolition and development stages of the project. Upon completion, it is contemplated that the community will be gated. The two existing entrances will be maintained but likely gated.
- Given the high end nature of the community high quality materials will be employed.
- Decisions regarding a construction entrance have not yet been made.
- Currently it is contemplated that the homes will range in square footage from 2,000 4,500 s.f. and will be high end in keeping with this quality location.
- Petitioner explained the buffer that is contemplated along the common boundary with the Rockbridge neighborhood.
- The Petitioner is not concerned about the risk of stalled project since it is confident of success and will be using a phased approach to vertical construction.
- Comments from several members of the Rockbridge community in attendance were positive.

CHANGES MADE TO THE PETITION AS A RESULT OF THE COMMUNITY MEETING AS OF THE DATE HEREOF:

Based on numerous discussions with leaders and residents of the Rockbridge community, Petitioner has committed to certain buffer standards along the common boundary as set out in the rezoning petition.


