

Background and Summary of Request:

These rezoning request relates to a minor change to the wording of note 2.5(c) on the currently approved conditional plan to clarity that the 25,000 square foot limit in building size for a single user relates only to retail/restaurant uses. Note 2.5(c) will be changed to read as follows: "No one single tenant or single fee ownership user may occupy more than 25,000 square feet of gross floor area on the ground floor for <u>retail and/or restaurant uses</u>." The bolded and underline section is being added.
