The Petitioner then opened the meeting to questions and comments. All citizens attending the meeting supported the change from Day Care Use to Educational Use.


CHANGES MADE TO THE PETITION AS A RESULT OF THE COMMUNITY MEETING AS OF THE DATE HEREOF:
