The Community Meeting was held on Tuesday, December 2, 2008 at 6:00 pm at the offices of J R McAdams at 6701 Carmel Road.

SUMMARY OF ISSUES DISCUSSED:

The Petitioner's representatives explained to the meeting attendees that the purpose of the rezoning petition is to accommodate an expansion of Carmel Commons Shopping Center. The expansion will include the below changes:

- New buildings will be constructed along Highway 51 and the existing gas station will be eliminated.
- The BB&T will relocate to the area along Highway 51 near the Boston Market.
- A minor amount of additional shop space within the existing in-line shopping center area.
- Driveways to the shopping center will be relocated to provide for more separation between the intersection of Highway 51 and Carmel Road to the driveways.

The discussion points during the course of the meeting include the following:

- The likely timetable for the expansion and
- Potential new tenants.

No opposition to the proposed expansion was expressed by any of the meeting attendees.
