
<u>Persons in attendance at meeting:</u> Attendance was taken with three (3) persons signing the Sign-in Sheet (see attached).

Kenny Abner and Chris Branch with The Boulevard Company along with Walter Fields and Susan Cannon of Kimley-Horn and Associates attended the meeting on behalf of the Petitioner.

#### Summary of issues discussed and changes made as a result of the meeting:

The community meeting on January 29<sup>th</sup> began with brief introductions and an explanation of the rezoning process including key dates for the petition. The meeting then moved to a discussion of where the project began and where the project has evolved to. It was pointed out that the request is to only modify the site plan that currently exists without adding any density or reducing any of the buffers that are currently approved for the site. Those in attendance had questions regarding the size, price and marketing of the units as well as the ownership of the units. The Petitioner indicated that they were willing to commit to a minimum unit size of 1,650 square feet and that based on market conditions, the units would be for sale. There were additional questions regarding the timeframe for the development of the project. The Petitioner indicated that there was no immediate time frame, but they were positioning themselves for a successful project in the future and that construction could begin as early as six to nine months from now. Those in attendance asked about similar developments that the Petitioner had constructed and were directed by the Petitioner to a number of projects throughout Charlotte. Other questions raised by those in attendance focused on the layout of the buildings on the site and the features of each unit including the patios, driveways and parking.

A number of site plan modifications have been made to the site plan as a result of review comments from staff agencies but at this time, no changes have been made as a direct result of the community meeting.
