We held a Community Meeting to discuss our rezoning petition 2009-034 concerning our property at 1301 South Boulevard at 6pm on April 28, 2009. Per City guidelines we sent letters on April 17, 2009 inviting property owners within 300 feet, as well selected community leaders, to attend this Community Meeting.

During our meeting we provided an overview of our rezoning petition along with an overview of the forthcoming renovation of the existing residential tower. Three of the four attendees have either lived in or been involved with the Dilworth Neighborhood for over 30 years. They were able to put the current proposed transformation of this property into a historical context that was quite compelling. They voiced a desire to continue to provide affordable housing in this location and indicated that it had been a great location for seniors housing over the years. They also expressed an interest in what was going to happen with the balance of the property that would be rezoned in the future. However, there were no requested modifications to the current rezoning petition.
