In order for the Mecklenburg County Water Quality Program to support this rezoning, the following recommendations should be implemented on site plans.

S.W.I.M. Stream Buffers (new)

S.W.I.M. stream buffer requirements apply as described on the following website: http://www.charmeck.org/Departments/StormWater/Contractors/SWIM+Ordinances+.ht m .

In addition, the buffer requirements specified in the post-construction storm water ordinance, as described on the website indicated above, also apply. In the event that

different requirements occur in the post-construction ordinance compared to the S.W.I.M. stream buffer ordinance, the more stringent will apply.

This plan proposes development within the S.W.I.M. stream buffer. Therefore, the petitioner must comply with Section 12.806 of the City of Charlotte SWIM Ordinance. A conceptual S.W.I.M. buffer mitigation plan has been submitted for the rezoning proposal; however, the proposed plan does not currently contain sufficient information (i.e. BMP design and pollutant removal criteria) to grant final approval. MCWQP will work with the petitioner to ensure that all impacts to the buffer are offset using appropriate mitigation techniques.
