COMMUNITY MEETING REPORT Petitioner: Liberty Healthcare Properties of Mecklenburg County, LLC Rezoning Petition No. 2011-041

This Community Meeting Report is being filed with the Office of the City Clerk and the Charlotte-Mecklenburg Planning Commission pursuant to the provisions of the City of Charlotte Zoning Ordinance.

<u>PERSONS AND ORGANIZATIONS CONTACTED WITH DATE AND EXPLANATION</u> OF HOW CONTACTED:

A representative of the Petitioner mailed a written notice of the date, time and location of the Community Meeting to the individuals and organizations set out on Exhibit A-1 attached hereto by depositing such notice in the U.S. mail on June 2, 2011. A copy of the written notice is attached hereto as Exhibit A-2.

DATE, TIME AND LOCATION OF MEETING:

The Community Meeting was held on Tuesday, June 14, 2011 at 7:00 PM at the Lower Providence Community Club Log Cabin located at 9735 Community House Road, Charlotte, North Carolina.

PERSONS IN ATTENDANCE AT MEETING (see attached copy of sign-in sheet):

The Community Meeting was attended by those individuals identified on the sign-in sheet attached hereto as Exhibit B. The Petitioner's representatives at the Community Meeting were Doug Whitman of the Petitioner, Scott Rasner of SFCS, Inc., the Petitioner's architect, Phillip Hobbs of Site Solutions, the Petitioner's landscape architect, and John Carmichael of Robinson Bradshaw & Hinson, P.A.

SUMMARY OF ISSUES DISCUSSED:

The Community Meeting was very informal because only two area residents attended the Community Meeting. Therefore, a formal presentation was not made by the Petitioner's representatives. Rather, the Community Meeting was a conversation between the Petitioner's representatives and the two area residents, both of whom live adjacent to the site in the Allyson Park neighborhood.

The Petitioner's representatives shared the Conditional Rezoning Plan with the area residents and discussed the Petitioner's development plans in the event that this Rezoning Petition is approved.

On the Conditional Rezoning Plan, the Petitioner has committed to install supplemental plantings within portions of the 50 foot Class C buffer located along the site's southern boundary line adjacent to the Allyson Park neighborhood. The Petitioner has also committed to install a berm in portions of this 50 foot Class C buffer. The area residents asked the Petitioner's representatives to describe and explain the supplemental plantings and berm, and the Petitioner's representatives did so.

CH-3048159 v1 3065964v1 22295.00012 One of the area residents expressed that he was not happy about the height of the building that would contain the independent living units, and he thought that building was too tall, particularly the four story portion of the independent living unit building.

The Petitioner's representatives stated that the four story portion of the independent living unit building was approximately 200 to 250 feet from this area resident's home, and that this building was designed to step up in height from two stories, to three stories and to four stories as you move away from the property line towards the center of the site. The Petitioner felt that this design was more aesthetically pleasing and was more sensitive to adjacent property owners then a design in which the entire building was three stories in height. This area resident reiterated his concern regarding the height of the independent living unit building, and the Petitioner agreed to have a cross section plan produced that would illustrate the relationship of the independent living unit building to this area resident's home as well as the sight lines from this area resident's home to the independent living unit building and to share the cross section plan with this area resident.

At the request of an area resident, the Petitioner's representatives described the vehicular access into the site and the vehicular circulation within the site. The Petitioner's representatives pointed out the service entrance into the site and the service areas, including the dumpster and loading and unloading areas. These areas are located within the center of the site. The Petitioner's representatives advised that service vehicles will not travel on the drive located closest to the Allyson Park neighborhood. The Petitioner's representatives also pointed out the location of the staff parking areas.

An area resident also expressed concerns about the traffic that would be generated by this proposed development. The Petitioner's representatives advised that the residents who live in the independent living units do not typically generate a great deal of peak hour traffic.

CHANGES MADE TO THE PETITION AS A RESULT OF THE COMMUNITY MEETING AS OF THE DATE HEREOF:

No changes have been made to the Conditional Rezoning Plan or to the Rezoning Petition as of the date of this Community Meeting Report as a result of the Community Meeting.

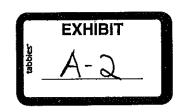
