Summary of Issues Discussed:


The meeting was opened using a large aerial map and showing the exact location of the subject properties. The current approved plan (Rezoning 2011-072) was described for student housing multifamily use up to maximum of 250 units and 750 bedrooms. Petitioner explained that this Site Plan Amendment to the current approved rezoning plan only decreases intensity of the project from a maximum density 750 bedrooms down to a maximum of 700 bedrooms. Petitioner explained that units will be rental apartment units specifically for students only. No other questions were asked by the attendee.
