DISCUSSION

Staff presented an overview of the text amendment. A question was asked about why CATS was pursuing this text amendment to eliminate the ability to advertise on information and advertising pillars. Staff responded that CATS is not interested in the information and advertising pillars as an advertising medium. The initial cost of the pillar is high compared to the flat, rectangular, signs approved by City Council in January. In addition, advertisers are more familiar with and demand the more traditional type signage versus signage on pillars. Staff supports the removal of the information and advertising pillars.

STAFF OPINION Staff agrees with the recommendation of the Zoning Committee.

PLANNING STAFF REVIEW

Background

- The recent approval of Petition 2013-064 allowed the Charlotte Area Transit System to place advertising signs on passenger rail platforms, with a sign plan approved by the Planning
- The signage allowed as a result of the approval of Petition 2013-064 replaces the signs placed on information and advertising pillars located on rapid transit platforms. As a result, allowances for signs on information and advertising pillars are no longer needed.

Proposed Request Details

- The text amendment contains the following provisions:
 - Remove the option to locate information and advertising pillar signs on a rapid transit platform.
