The proposed project may be subject to certain air quality permitting requirements in accordance with Mecklenburg County Air Pollution Control Ordinance ("MCAPCO") Regulation 1.5111 - Applicability". A letter of notification and a copy of the regulations will be mailed directly to the parcel owner.

Storm Water Services

The requirements of the post-construction storm water ordinance for the City of Charlotte should be applied to the proposed rezoning. Impaired Streams:

The property represented in this rezoning drains to surface waters listed on North Carolinas Department of Natural Resources 303(d) list of impaired streams. Irwin Creek is listed for copper, lead, zinc, turbidity, ecological/biological integrity of fish communities, and fecal coliform due to pollution discharges. <u>By properly controlling pollutants both during and after construction you can help restore these surface waters.</u> More information on North Carolina's impaired waters and 303(d) list can be found at <u>http://portal.ncdenr.org/web/wq/ps/mtu/assessment</u>.
