Summary of issues discussed and changes made as a result of the meeting:

Mr. Fields opened the presentation with a description of the site and the proposed development as well as an overview of the rezoning process. There was some discussion about the road and sidewalk improvements that would be installed, especially along Ott Street. There was discussion about the possibility of noise from the site but it was noted that the zoning rules for facilities with outdoor entertainment facilities would likely reduce any impacts. There was general approval expressed for the project that will renovate an old cookie factory and that it would bring added opportunities to the neighborhood. But no real questions or objections about the proposed use or the density at that location.

A number of site plan modifications have been made to the site plan as a result of review comments from staff agencies but no changes have been made as a direct result of the community meeting.
