# COMMUNITY MEETING REPORT Petitioner: Essex Homes Southeast, Inc.

### DATE, TIME AND LOCATION OF MEETING:

The Community Meeting was held on Wednesday, May 4<sup>th</sup>, 2016 at 6:00p.m. at the Wilmore Community Center located at 501 West Boulevard, Charlotte, NC 28203.

### PERSONS IN ATTENDANCE AT MEETING (see attached copy of sign-in sheet):

The Community Meeting was attended by those individuals identified on the sign-in sheet attached hereto as Exhibit C. The Petitioner was represented at the Community Meeting by: Brian Iagnemma, President of Land, Essex Homes Southeast, Inc., Jeremy Smith, Land Supervisor, Essex Homes Southeast, Inc. and Brian Smith, P.E., Urban Design Partners.

### **SUMMARY OF PRESENTATION/DISCUSSION:**

The Petitioner's agent, Brian Iagnemma, welcomed the attendees and introduced the Petitioner's team. Brian Iagnemma indicated that the Petitioner proposed to rezone an approximately 0.67 site (the "Site") at 529 W. Summit Avenue, Charlotte, NC 28203 from the I-2 to UR-1. Brian Iagnemma explained the rezoning process in general and stated that the purpose of the meeting was to discuss the rezoning request and the conditional site plan and respond to questions and concerns from nearby residents and property owners.

Brian Smith then presented the site plan and pointed out various commitments made by the Petitioner. Brian Iagnemma and Jeremy Smith showed proposed architectural elevations and discussed the design of the proposed homes. He used the elevations and renderings to explain the homes' design concepts, and production operations.

### **DETAILED MINUTES:**

Justin Lane, Wilmore HOA President

Welcomed Brian Iagnemma, Brian Smith and Jeremy Smith into the Wilmore Community Center.
 He expressed approval of our rezoning petition and proposed architectural design of the four homes.

### Donna Browning, 1546 Wilmore Drive

• Expressed approval and excitement for Essex's plans for the property. She explained the history of the parcel concerning various businesses. As an expolice officer, she is concerned with the safety of the community and believes constructing homes on the parcel will eliminate the possibility of future business and industrial operations on the parcel which could lead to vagrancy. Ms. Browning advised that safety and security of the Essex employees, tools and equipment should be considered during home construction and that an Essex contact number be given to the community police officer.

### Darius Johnson, 1536 Merriman Avenue

• Mr. Johnson was in approval of the rezoning to four single family homes and was pleased to know that the property was being rezoned to residential. Mr. Johnson placed emphasis on the architectural elements and expressed his thoughts that the elevations proposed needed to be more "bungalow" style and consistent with the character found within Wilmore. Furthermore, Mr. Johnson inquired about Essex's plans for the vacant land parcel directly across from 529 W. Summit Avenue. It was explained by Brian Iagnemma that Essex does not control the said vacant parcel and could not speak to the outcome of any industrial or business plans for it. Mr. Johnson rebutted that Wilmore residents are in opposition of the proposed "rail yard" and desire for a community park to be built in its stead.


