COMMUNITY MEETING REPORT

Petitioner: Benson Ejindu Rezoning Petition No. 2016-62

This Community Meeting Report is being filed with the Office of the City Clerk and the Charlotte-Mecklenburg Planning Commission pursuant to the provisions of the City of Charlotte Zoning Ordinance.

PERSONS AND ORGANIZATIONS CONTACTED WITH DATE AND EXPLANATION OF HOW CONTACTED:

A representative of the Petitioner mailed a written notice of the date, time, and location of the Community Meeting to the individuals and organizations set out on **Exhibit A-1** attached hereto by depositing such notice in the U.S. mail on April 6, 2016. A copy of the written notice is attached hereto as **Exhibit A-2**.

The Community Meeting was held on Thursday, April 14, 2016 at 6:00 PM on site, located at 7401 The Plaza Road, Charlotte, NC, 28215.

PERSONS IN ATTENDANCE AT MEETING (see attached copy of sign-in sheet):

The Community Meeting was attended by those individuals identified on the sign-in sheet attached hereto as **Exhibit B**. The Petitioner was represented at the Community Meeting by Richard Callahan of HensonFoley.

SUMMARY OF PRESENTATION/DISCUSSION:

The Petitioner's agent, Richard Callahan welcomed the attendees and introduced himself and the Petitioner. Richard Callahan indicated the Petitioner proposed to rezone an approximately 1.23 AC site located on the north side of The Plaza Road between E WT Harris Blvd and Northridge Middle School from R-3 zoning district to O-1 (CD) zoning district. Richard Callahan explained the rezoning process in general and stated the purpose of the meeting was to discuss the rezoning request, the conditional site plan and respond to questions and concerns from nearby residents and property owners.

Richard Callahan provided some background information about the Petitioner's experience and projected operation of the proposed facilities. He indicated the proposed access to the site would be from The Plaza Road, this access point would be a full movement access drive that would be aligned with the driveway on the opposite side of the street.

Likewise, Mr Callahan presented the proposed Site Plan highlighting the location of the office building being located towards the front of the site with the required parking to the side and rear of the building. Sidewalks are proposed to service the building and to provide access from the building to the public sidewalk adjacent to The Plaza Road.

Richard Callahan then introduced the group to the architectural renderings, explaining the conceptual function of the building and then highlighted the proposed detailing of the building elevations. The maximum proposed building size would be 10,000 square feet with a maximum building height of 40'. The proposed use of the building would be for a General Office Use and Medical Office Use.

A resident of the area attending the meeting inquired about the stormwater detention pond. Richard Callahan explained the use and function of the required stormwater pond and how it would work with the site. After some additional discussion the local resident requested the stormwater pond to be fenced in with a 5'HT fence (min) to discourage un-warranted access to the pond. The Petitioner agreed to the request to install a fence around the storm pond.

The local residences/attendees mentioned to the Petitioner that he would be required to provide a 5' wide sidewalk. The Petitioner and Richard Callahan agreed and indicated a sidewalk along The Plaza Road would be provided per the City of Charlotte's requirements.

A residence in attendance mentioned the proposed development appears to work well with the surrounding uses. However, she requested if the Petitioner could limit the hours of operation <u>not</u> to be 24 hour per day. The Petitioner agreed to her request and they mutually agreed upon the hours of operation from 6:00 AM to 10:00 PM.

The meeting was adjourned.
