No trees can be planted in the right of way on Steele Creek Road without permission of NC Department of Transportation and the City Arborist's office. Trees in the right of way on Ed Brown Road are protected by the Tree Ordinance. No trees can be removed from or planted in the right of way on Ed Brown Road without permission of the City Arborist's office. Contact Laurie Reid (704-336-5753) at the City Arborist's office for a permit before removing trees in the right of way.

The petitioner must submit a tree survey for all trees 2" or larger located in the rights of way. In addition, the survey shall include all trees 8" or larger in the setback of all roads.

No trees can be removed from or planted in the right of way without permission of NC Department of Transportation and the City Arborist's office. The petitioner must submit a tree survey for all trees 2" or larger located in the rights of way of all three roads. In addition, the survey shall include all trees 8" or larger in the setback of all three roads.
