Background and Summary of Request:

This Petition involves a request to rezone the 23.30 acre Site from the CC SPA (Commercial Center Site Plan Amendment), UR-C (CD) (Urban Residential - Commercial (Conditional District)) zoning district to UR-C (CD) zoning district. The rezoning plan proposes to develop the Site as a Multi-Family Residential use. The proposed buildings will have a minimum set back of 14' along U.S. Highway 29 and a maximum set back of 35'. The Site is currently not developed.

The site plan associated with the Rezoning Petition proposes to develop the Site with eight (8) residential multi-family buildings.
