Summary of issues discussed and changes made as a result of the meeting: About 20 people attended the community meeting. The Petitioner discussed the history of the Prosperity Village area and how it came to be to set the context for the discussion. The Petitioner introduced the project and summarized the work that had been going to develop plans for the use of the property for multifamily community, including two prior meetings with leaders in the area.. There was a specific question asked about a potential ground water issue with prior use of the site. The applicant noted that the site had been cleared by environmental officials. There were a few questions about the site plan and possible uses on the site but no significant issues were raised. There were several comments about traffic in the area and the still incomplete road network. It was noted that there are times of existing congestion on streets in the area but CDOT has not raised a concern about traffic from the site. All in attendance that expressed an opinion understood what the request was and there was some opposition expressed to the proposal and to new development in the general context of preferences for no further development in the area. After the meeting was concluded several attendees offered positive comments about the proposal.

No site plan modifications have been made to the site plan as a direct result of the community meeting.
