<u>Persons in attendance at meetings:</u> Attendance was taken with approximately 50+ persons attending the meeting (39 signing the Sign-in Sheets attached). The Petitioner has previously held a meetings with the Church that adjoins the site.

Russ Sinacori, Frank Ed Estridge, Frank McMahan, and Walter Fields attended the meeting on behalf of the Petitioner.

Summary of issues discussed and changes made as a result of the meeting:

Mr. Fields opened the presentation with a description of the site and the proposed development as well as an overview of the rezoning process. He explained that he believed that the density and scale of the development was appropriate for the small site in question. There were numerous questions about the site plan, building location and orientation, area-wide traffic, storm water and the project edges There were many questions and comments from members of the church about the historic nature of the Church and its properties and how the proposed development would impact the Church property. An attorney in the room asked many questions about the title for the property and whether the site size on the plan was accurate. He also stated his belief that the plan as proposed was not consistent with the most recently adopted plan that included this site. It was suggested that the Petitioner should consider some other zoning district.

A number of site plan modifications have been made to the site plan as a result of review comments from staff agencies and from the community meetings. The Petitioner deferred the processing of the case to follow-up on the title issue raised at the meeting. That time was also used to modify the site plan to reduce the number of units from 6 to 5 and to eliminate one of the two driveways to the site from Providence Church Lane. In addition, a follow-up meeting was held with community representatives to review the changes made to the site plan.
