COMMUNITY MEETING REPORT PETITIONER: HARRISON TUCKER & JOHN PEROVICH

REZONING PETITION NO.: 2018-012

This Community Meeting Report is being filed with the Office of the City Clerk and the Charlotte-Mecklenburg Planning Commission pursuant to the provisions of the City of Charlotte Zoning Ordinance.

PERSONS AND ORGANIZATIONS CONTACTED WITH DATE AND EXPLANATION OF HOW CONTACTED:

A representative of the Petitioner mailed a written notice of the date, time and location of the Community Meeting to the individuals and organizations set out on Exhibit A attached hereto by depositing such notice in the U.S. mail on February 23, 2018. A copy of the written notice is attached hereto as Exhibit B.

DATE, TIME AND LOCATION OF MEETING:

The Community Meeting was held on Wednesday, March 7 at 6:00 pm. at the Birdsong Brewing Company, 1016 N. Davidson St., Charlotte, NC 28206.

PERSONS IN ATTENDANCE AT MEETING (see attached copy of sign-in sheet):

The Community Meeting was attended by those individuals identified on the sign-in sheet attached hereto as <u>Exhibit C.</u> The Petitioner was represented at the Community Meeting by Harrison Tucker and Russell Fergusson.

SUMMARY OF PRESENTATION/DISCUSSION:

The Petitioner's agent, Russell Fergusson, welcomed the attendees and introduced himself and Harrison Tucker, the Petitioner. Petitioner presented the proposal to rezone seeking to rezone the approximate 0.16 acres site (the "Site") located at 1401 N. Davidson St. from the R-5 zoning district to UR-2 (CD) zoning district. The agent explained the rezoning process in general and stated that the purpose of the meeting was to discuss the rezoning request and the conditional site plan and respond to questions and concerns from nearby residents and property owners. The meeting was attended by neighbors and neighborhood leaders.

Mr. Tucker and Mr. Fergusson presented the site plan and explained the basic elements of the proposed development, including the efforts to move forward with plans that will include up to five residential units and the inclusion of an affordable unit for sale. Petitioner and attendees were able to sit at one large table and carry out an extended conversation regarding the petition. Petitioner explained the basic and the standards and limits being incorporated into the revised Site Plan. The petitioner addresses the need for "missing middle" options for the residential market in the area. Extended conversation was had regarding the current developments of large single-family homes that are changing the character of the neighborhood and pricing out residents. The neighborhood president discussed his struggle with how to address the rezonings and rapid growth in development created by the light rail project. The conversation addressed that many attendees supported the petition because it would create more affordable housing options that can limit the impact of gentrification and allow for more economic diversity—including an affordable for sale unit. Some concerns over the density and height were discussed. Petitioner and attendees also discussed the sidewalk and elevation issues that led Petitioner to modify the sidewalk and planting strips. Petitioner

explained the proximity to light rail and the greenway entrance across the street, as reasons why the proposed density is appropriate.

Petitioner answered community questions regarding the setbacks, the heights of the building, the location of garages, improvement of the sidewalk but still matching existing and neighboring properties, the parking plans, and the proposed density. Petitioner also answered questions regarding the building materials and environmentally conscience goal of a sustainable and net-zero development. The general consensus towards the proposal was positive and that this would be an improvement over the anticipated development of a very large single-family home.

Petitioner explained its understanding that the HDC process would be a separate process and that confirmation of final design details would be determined in the HDC process.

Included in attendance were approximately eight area residents including several people that live and own property on the same block as the rezoning.
