The Community Meeting was held on May 23, 2018 at 5:30pm at Our Lady of Consolation Church 2301 Statesville Avenue Charlotte, NC 28206.

The Community Meeting was attended by those individuals identified on the sign-in sheet attached hereto as Exhibit C. The Petitioner was represented at the Community Meeting by Jeff Mangas and Greg Hartley with EMH&T; Matt Stiene, Raymond "Raki" McGregor, Dr. Michael Hoben, and Tamara Smith with Novant Health; and Frank Little, and Darrel Williams with Neighboring Concepts.

SUMMARY OF PRESENTATION/DISCUSSION:

The Petitioner's agent, Jeff Mangas, welcomed the attendees and introduced the Petitioner's team. Mr. Mangas indicated that the Petitioner proposed to rezone an approximately 1.52 acre site (the "site") located at 2701 Statesville Avenue, Charlotte, NC from the R-22MF zoning district to O-1 (CD) zoning district. Mr. Mangas explained the rezoning process in general and stated that the purpose of the meeting was to discuss the rezoning request and the conditional site plan and respond to questions and concerns from nearby residents and property owners.

Mr. Stiene provided background information about the Petitioner's experience and the typical operation of its facilities. He then presented the site plan and pointed out various commitments made by the Petitioner. Mr. Stiene further discussed the design of the proposed facility and explained the facility's design concepts, and operations.

Mr. Mangas commenced with a digital presentation and description of plans. He then introduced Mr. Stiene. Following Mr. Mangas' presentation, Mr. Stiene reported that the existing parcel would be smaller. Mr. Stiene then introduced Mr. McGregor, Dr. Hoben, Ms. Smith, Mr. Williams, and Mr. Little.

Mr. McGregor stated that he will be conducting neighborhood meetings for design input of the clinic. Mr. Stiene continued with the presentation explaining that there will be a 7500 square foot medical clinic and 4000 square foot recreation/community center for future use. Mr. Stiene then discussed the schedule of events as represented in the presentation.

Dr. Hoben discussed the clinic plans and goals. The clinic will be for acute care (cold, sprains) as well as chronic disease care (high blood pressure, diabetes.) The goal is to be an innovation corridor clinic providing tele-health, nutrition, and have a pharmacy in the future. Dr. Hoben also stated that they plan to integrate behavioral health as part of the clinic as well.

After the completion of the presentation, Mr. Stiene asked for questions or comments from the floor.

Comment: Ms. Martinez expressed appreciation of thoughts and goals for innovation corridor.

Question: What would the hours be?

Response: This would be something that would come from the needs of the community, which would

be expressed during the community meetings.

Question What is the anticipated construction schedule?

Response: Dr. Hoben stated that they anticipated completion in the 1st quarter of 2020. He also

reported that funding is complete currently.

Question: How do you plan on rolling out community engagement?

Response: Mr. McGregor stated that he would be seeking help from community leaders and faith

leaders. He will also be looking for way to maximize community involvement. Dr. Hoben

wants to open a clinic that serves the needs of the community.

Comment: Would like to see a leading edge/outside of the box clinic.

Response: Dr. Hoben stated that the top goal is to create a place to meet the needs of the

community.

Question: What else or what other services do you see for the neighborhood?

Response: Mr. Henderson stated they are still trying to attract grocer and Novant is trying to solidify

users. Dr. Hoben stated that as Novant engages more interest in neighboring parcels, they

envision a space for additional neighborhood needs.

Question: Will this be behavioral health or mental health?

Response: Dr. Hoben stated that they are one in the same. Behavioral health has a broader

definition.

Question: Will there be an urgent care?

Response: Dr. Hoben stated this will depend on community need. The goal is to provide care in both

traditional and new more innovative ways.

Comment: Mr. Gaston stated that he hopes this will be a catalyst for development. He welcomed

Novant to start growth that will help the neighborhood.

Comment: Ms. Martinez stated that Camp NE kept neighbors informed. Follow through from Novant

will help with involvement.

Response: Dr. Hoben stated that if they do not follow through with keeping the community informed

and involved they will fail. He would like to put together a team to make sure they meet

the community needs.

Mr. McGregor stated that Novant feels they are being invited into the neighborhood. The goal is to connect with the neighborhood but will need the neighborhoods help with that.

Mr. Stiene wants to maximize usage for neighborhood.

Question: Will there be parking screening?

Response: Mr. Mangas stated that screening will be required by code.

Mr. Stiene stated the team will ensure that the screening is adequate.

Question: What will the signage be?

Response: The signage likely be co-branded from the foundation and Novant.

Comment: Prefer to be convenient with hours of primary care

Question: Can we schedule appointments?

Response: Dr. Hoben stated that yes, both scheduled and urgent appointments are the goal

Question: Why is the clinic so small?

Response: Mr. Stiene stated this is to maximize use

Dr. Hoben stated this is also in part of donation based and size is intentional to maximize

operational use.
