Property: \pm 4.35 acres located at S. Tryon Street between Wright's Ferry

and Wrights Crossing Drive (the "Site").

This Community Meeting Report is being filed with the Office of the City Clerk and the Charlotte-Mecklenburg Planning Department pursuant to Section 6.203 of the City of Charlotte Zoning Ordinance.

PERSONS AND ORGANIZATIONS CONTACTED WITH DATES AND EXPLANATIONS OF HOW CONTACTED:

The required Community Meeting was held on Thursday, August 16th, 2018. A representative of the Petitioner mailed a written notice of the date, time and location of the Community Meeting to the individuals and organizations set out on **Exhibit A** by depositing the Community Meeting Notice in the U.S. mail on 8/6/2018. A copy of the written notice is attached as **Exhibit B**.

TIME AND LOCATION OF MEETING:

The Community Meeting required by the Ordinance was held on Thursday, August 16th, 2018 at 7:00 PM, at Pleasant Hill Presbyterian Church, 15000 York Road, Charlotte, NC 28278.

PERSONS IN ATTENDANCE AT MEETING:

The sign-in sheet from the required Community Meeting is attached as **Exhibit C**. The Petitioner's representative at the required Community Meeting were Mark Blythe with Profiles Homes and Phillip Hobbs with Benesch. Also in attendance was Keith MacVean with Moore & Van Allen, PLLC.

SUMMARY OF ISSUES DISCUSSED AT MEETING:

I. Overview of Petitioner's Presentation.

Introduction and Overview of Development Plan.

Keith MacVean opened the meeting and welcomed everyone in attendance. Mr. MacVean then gave a brief over view of the Site location and proposed rezoning plan.

Mr. MacVean explained that this Petition involves a request to rezone an additional \pm 4.35 acres from R-3 and B-D(CD) to R-12MF(CD) to allow the Petitioner to develop the Site with up to 33 townhomes for sale (one-family attached dwelling units) as a second phase of the Wrights Crossing a townhome for sale residential community, which is currently under development on a parcel behind the Site. Phase One of Wrights Crossing was approved in 2016 and will contain 69 townhome units and is constructing a new public street that will connect Phase One and Phase Two of Wrights Crossing to S. Tryon Street.

The proposed 33 townhomes for sale will be oriented toward the public streets currently under development by as part of phase one of Wrights Crossing (Wrights Crossing Drive and Target Lane) as well as a new public street that will connect these two new public streets.

The meeting was opened to questions.

II. Summary of Questions/Comments and Responses:

One attendee inquired about the addition of a traffic signal at Wrights Crossing Drive and S. Tryon Street. It was explained that the Site does not qualify for a signalized intersection.

Another attendee asked about the location of the pool. The Petitioner pointed out the proposed location for the pool, which is part of Phase One, as well as Stormwater detention and visitor parking areas.

Attendees inquired as to the number of units being constructed. Phase One is zoned for 75 units and the Petitioner plans to build 69 units. Phase Two, which is the Site sublet to the new rezoning petition, will add up to 33 units.

One attendee asked about the buffers in Phase One and if they would be affected by Phase Two. The Petitioner expressed that the Phase One buffers would not be disturbed.

Mr. MacVean reviewed upcoming City Council meeting dates for the petition and thanked everyone in attendance.

The meeting was adjourned.

Background and Summary of Request:

This Petition involves a request to rezone the \pm 4.35 acre Site from R-3 and B-D(CD) to R-12MF(CD). This rezoning petition will allow the Petitioner to develop the Site with up to 33 townhomes for sale (one-family attached dwelling units) as a second phase of the Wrights Crossing a townhome for sale residential community, which is currently under development on a parcel behind the Site. A portion of the Site was rezoned to B-D(CD) in 2016 to allow the development of a public street, or to be used in conjunction with a climate controlled storage facility that was proposed on the adjoining parcel, which was ultimately not approved by the City Council. The remainder of the Site is zoned R-3 and is currently under development with a new public street that will be used to access the first phase of Wrights Crossing. This new public street (Wrights Crossing Drive) will also provide access to the rezoning Site.

The site plan associated with the Site proposes to develop up 33 townhomes for sale on the Site, these proposed units will be oriented toward the public streets currently under development by as part of phase one of Wrights Crossing (Wrights Crossing Drive and Target Lane) as well as a new public street that will connect these two new public streets.
