# COMMUNITY MEETING REPORT Petitioner: CMPD University City

**Rezoning Petition No. 2018-082** 

This Community Meeting Report is being filed with the Office of the City Clerk and the Charlotte-Mecklenburg Planning Commission pursuant to the provisions of the City of Charlotte Zoning Ordinance.

#### PERSONS AND ORGANIZATIONS CONTACTED WITH DATE AND EXPLANATION OF HOW CONTACTED:

A representative of the Petitioner mailed a written notice of the date, time and location of the Community Meeting to the individuals and organizations set out on Exhibits A and B attached hereto by depositing such notice in the U.S. mail on Friday, August 3, 2018. A copy of the written notice is attached hereto as Exhibit C.

#### **DATE, TIME AND LOCATION OF MEETING:**

The Community Meeting was held on Thursday, August 16, 2018 at 5:00 PM at 6020 University Pointe Boulevard, Charlotte, NC 28262.

#### PERSONS IN ATTENDANCE AT MEETING (see attached copy of sign-in sheet):

The Community Meeting was attended by those individuals identified on the sign-in sheet attached hereto as Exhibit D. The Petitioner was represented at the Community Meeting by Captain Allan Rutledge (CMPD), Monifa Woodside and Ahmad Sabha with the City of Charlotte. Also in attendance was Ashley Love with ADW Architects and Jason Dolan with Timmons Group.

#### **SUMMARY OF PRESENTATION/DISCUSSION:**

The Community Meeting was a drop-in style presentation. The representatives welcomed the attendees as they arrived, gave a short description of the project which included the project size and reason for rezoning the property from O-2, INST and MUDD-O to TOD-MO and provided each attendee with a description of the rezoning process. The representatives then answered any questions referencing the Rezoning Plan and Building Elevations that were on display

#### **SUMMARY OF QUESTIONS/COMMENTS AND RESPONES:**

- Several attendees remarked on the building's orientation. Ms. Love explained that several
  factors affected the location of the building and main entrance location from the flow of traffic
  along North Tryon Street to the shape and size of the site.
- The total square footage of the building was questioned. Ms. Love responded that the size of
  the site directly impacted the building square footage and the decision to utilize a two-story
  structure. Captain Rutledge added that although this project will become the first two-story
  station, it was necessary in order to achieve the necessary space for their officers, staff and
  needs.

- One attendee who is involved with the University City Partners (UCP) questioned the use of surface parking on the project and how that is not consistent with UCP's goals for development in the University City area. The response was that a structured parking option was considered but the size and shape of the parcel didn't allow for an efficient design which would have negatively affected the budget.
- Several attendees asked about the project schedule. The response was that construction is planned to begin in the Spring of 2019 and be complete by April of 2020.
