# PERSONS AND ORGANIZATIONS CONTACTED WITH DATES AND EXPLANATIONS OF HOW CONTACTED:

The required Community Meeting was held on Tuesday, January 29<sup>th</sup>, 2019, a representative of the Petitioner mailed a written notice of the date, time and location of the Community Meeting to the individuals and organizations set out on **Exhibit A** by depositing the Community Meeting Notice in the U.S. mail on 1/16/2019. A copy of the written notice is attached as **Exhibit B**.

#### TIME AND LOCATION OF MEETING:

The Community Meeting required by the Ordinance was held on Tuesday, January 29, 2019 at 6:00 PM, at Mayfield Memorial Baptist Church, 700 W. Sugar Creek Road, Charlotte, NC 28213.

#### PERSONS IN ATTENDANCE AT MEETING:

The sign-in sheet from the required Community Meeting is attached as <u>Exhibit C</u>. The Petitioner's representative at the required Community Meeting were Julie Porter, Liz Ward and Fred Dodson with The Charlotte Mecklenburg Housing Partnership, Frank Quattrochi with Shook Kelly, and Dr. Wherry with Mayfield Memorial Baptist Church. Also in attendance were Keith MacVean and Dujuana Keys with Moore & Van Allen, PLLC.

#### SUMMARY OF ISSUES DISCUSSED AT MEETING:

#### I. Overview of Petitioner's Presentation.

#### **Introduction and Overview of Development Plan.**

Keith MacVean opened the meeting and thanked everyone in attendance. Mr. MacVean reviewed the conditional rezoning process and anticipated schedule. Mr. MacVean then gave an overview of the site location and proposed zoning change. He then introduced Julie Porter with The Charlotte Mecklenburg Housing Partnership.

Ms. Porter gave the audience an overview of CMHP, which has been a non-profit housing partnership in the Charlotte region for over 30 years. They are a private neighborhood developer that assists in home ownership and affordable rental options for Charlotte area residents. Thus far

the CMHP has developed 22 projects in the area. Ms. Porter then introduced Dr. Peter Wherry with Mayfield Memorial Baptist Church.

Dr. Wherry has been the pastor of Mayfield Memorial for 12 years and saw the need to address the affordable housing crisis in Charlotte. Over the years, the church has made improvements to the homes on their property but realized they are able to do more. In this, the church has offered their land, surrounding the church, to develop an affordable housing community in partnership with the Charlotte Mecklenburg Housing Partnership. The proposed development will work to promote affordable mixed income rental living options and a sense of community.

Through this development, the church and Dr. Wherry propose to:

- promote mixed income housing;
- add value to the community;
- create a community where residents can afford to work and live;
- work towards providing a park and open greenspace for the community; and
- create a model that is duplicable for other faith communities to follow.

Mr. MacVean gave a brief overview of the site features and proposed development. This rezoning proposes to construct up to fifty (50) units using a combination townhomes and garden style walk-up apartment buildings, an open park/greenspace, as well as additional parking for the church.

With this rezoning, The Charlotte Mecklenburg Housing Partnership in partnership with Mayfield Memorial Baptist Church, intends to promote affordable housing and a sense of stability within the community.

The meeting was then opened for questions.

#### **II.** Summary of Questions/Comments and Responses:

Attendees inquired about the unit types and income requirements. Ms. Porter explained that the current proposed project that was submitted for Tax Credit financing in January 2019 will include 26% of the units will be for residents earning <30% AMI, 14% of the units will be for residents earning <50% AMI, 50 % will be for residents earning <60% AMI, and 5 units will be for residents earning up to 80% AMI. The community will accept housing vouchers and subsidies. The site plan proposes to include 22 townhome units and 28 garden style apartments. Eight (8) units are anticipated to be 1 bedrooms units, 40 units will have 2 bedrooms, and 2 units will have 3 bedrooms. All future residents will be subject to background checks and must adhere to all rules in accordance with the community or be subject to eviction. Current residents of the church owned homes will have first opportunity to apply for units in the new development and will remain on site until construction begins.

Attendees had concerns about traffic on Munsee Street and Yuma Street and asked if access could be restricted to Sugar Creek Road. There is currently access to the church along West Sugar Creek Road and an additional entry for the future development is not feasible due to block size and CDOT

request. The entries on Munsee Street and Yuma Street will better serve the newly developed community.

Attendees inquired how this development is being funded. The Petitioner is in the process of applying for Housing Trust Fund Dollars as well as tax credits to allow for the development to be constructed.

One attendee expressed concern with the location of the development within the community and inquired if the Charlotte Mecklenburg Housing Partnership has constructed previous communities within established neighborhoods. Ms. Porter explained that their developments are often placed in the midst of communities to further promote the mixed-income living model.

Dr. Wherry expressed that he and his church believe this is the best use of the land for this neighborhood. They have the land and the community has a need for affordable housing. A vacant lot isn't in the best interest of the community and current homes on the site are not enhancing the value of the neighborhood. With this partnership, Dr. Wherry and Mayfield Memorial Baptist Church intend to promote growth within the community.

Keith MacVean thanked everyone for their attendance and the meeting was adjourned.
