COMMUNITY MEETING REPORT

Petitioner: Ardent Acquisitions LLC

Rezoning Petition No. 2019-005

This Community Meeting Report is being filed with the Office of the City Clerk and the Charlotte-Mecklenburg Planning Commission pursuant to the provisions of the City of Charlotte Zoning Ordinance.

<u>PERSONS AND ORGANIZATIONS CONTACTED WITH DATE AND EXPLANATION</u> OF HOW CONTACTED:

A representative of the Petitioner mailed a written notice of the date, time and location of the Community Meeting to the individuals and organizations set out on <u>Exhibit A-1</u> attached hereto by depositing such notice in the U.S. mail on February 22, 2019. A copy of the written notice is attached hereto as Exhibit A-2.

DATE, TIME AND LOCATION OF MEETING:

The Community Meeting was held on Thursday, March 7, 2019 at 6:30 PM in the Fellowship Hall at Pritchard Memorial Baptist Church (a/k/a Pritchard at South End) located at 1117 South Boulevard in Charlotte, North Carolina.

PERSONS IN ATTENDANCE AT MEETING (see attached copy of sign-in sheet):

The Community Meeting was attended by those individuals identified on the sign-in sheet attached hereto as <u>Exhibit B</u>. The Petitioner's representatives at the Community Meeting were Tyson Reilly of the Petitioner, David Booth of LandDesign and John Carmichael of Robinson Bradshaw & Hinson, P.A.

SUMMARY OF ISSUES DISCUSSED:

Only one person attended the Community Meeting, and he is a representative of the owner of the adjacent parcel of land located to the east of the site. This attendee was aware of the Petitioner's site plan and he was not interested in a presentation regarding the rezoning request. The attendee had four matters that he wanted to discuss with the Petitioner.

First, he asked how the re-working of the culvert on the adjacent parcel would be handled. David Booth stated that the culvert would be re-worked through the rezoning site and that it has not been determined if any work needs to occur on the adjacent parcel of land. John Carmichael stated that the Petitioner's representatives would follow up with the attendee and Frank Horne about this matter.

Second, he asked if the Petitioner would agree to install enhanced sound mitigation on the eastern exterior wall of Building 12, Building 13 and Building 14. Tyson Reilly stated that the Petitioner would agree to do so.

Third, he asked if trees and shrubs would be installed in the 10 foot wide landscape area located along the eastern boundary line of the site, and David Booth confirmed that trees and shrubs would be installed in this landscape area.

Fourth, he asked if the fence to be installed along the eastern boundary line of the site could be 8 feet in height rather than 6 feet in height. Tyson Reilly stated that the Petitioner would agree to install an 8 foot tall fence if allowed under the Zoning Ordinance. If an 8 foot tall fence is not

allowed, then the Petitioner would install a 6 foot tall fence. John Carmichael stated that the pretty side of the fence would face the adjacent parcel of land.

John Carmichael thanked the attendee for attending the meeting, and the meeting was adjourned.

CHANGES MADE TO THE PETITION AS A RESULT OF THE COMMUNITY MEETING AS OF THE DATE HEREOF:

The following changes were made to the Rezoning Plan as a result of the Community Meeting:

- 1. Petitioner committed to install enhanced sound mitigation on the eastern exterior wall of Building 12, Building 13 and Building 14.
- 2. Petitioner committed to install an 8 foot tall fence along the eastern boundary line of the site if allowed under the Zoning Ordinance. If not allowed under the Zoning Ordinance, the Petitioner will install a 6 foot tall fence. The finished side of the fence will face the adjoining parcel of land located to the east of the site.
