## General Review Information

The site is at the signalized intersection of Providence Road (major thoroughfare) and Strawberry Hill Drive (local) and is located in a wedge outside Route 4.

### Active City Projects Near the Site:

- Providence Road Sidewalk Improvements (Greentree Drive to Know Oak Lane)
  - This project will construct sidewalk on the southwest side of Providence Road from Greentree Drive to Knob Oak Lane.
- Providence Sidewalk (Providence Village Lane to E. Barden Road)
  - This project will involve installing sidewalk along west side of Providence Road from Providence Village Lane southward to East Barden Road

*CDOT's review of this rezoning petition is intended to ensure consistency with the Transportation Action Plan (TAP) which seeks to ensure that the City's transportation network supports current and future land uses and includes streets that provide safe and comfortable mobility for motorists, pedestrians, bicyclists, and transit users.*

*This document is primarily for communication to Planning Department staff as part of the overall City staff analysis of the rezoning petition and includes an overall summary of the case from a transportation perspective, information on trip generation, and resolved or outstanding site plan concerns. Additional advisory information about the driveway permit process is provided for information only.*

Based on our review of the petition, we offer the following information for your consideration.

## Transportation Summary

This site is located along a Major Thoroughfare and a Local Road. The site conducted a Traffic Impact Study as part of phase one and took into consideration this future expansion. The site committed to improvements at Strawberry Hill Drive by installing a new traffic signal with additional turn lanes, and upgrading existing ramps. CDOT continues to request the extension of Providence Road sidewalk to Cloister Drive to provide better access to CATS bus stops to promote transit use along this corridor. The sidewalk request is in line with the City goals of installing sidewalk along Providence Road to promote overall walkability.



- ~~**Curbline** The proposed zoning district has a setback measured from back of the existing or proposed future curbline. The location of the future back of curb has been established per approved Accela permit LDUMUDD-2016-00027.~~
- ~~**Traffic Study** A Traffic Impact Study is necessary for the complete review of this petition. CDOT has requested more specific information is given so that we can more accurately generate trip generation for this site and understand if and what further mitigations would be necessary.~~ **Comment Rescinded:** After further discussion with petitioner and investigating into the site, there was a previous TTM conducted for 830 dwellings, this study took account for adjacent development as well. After review of the required mitigations, it was found that the development has already implemented most of the necessary traffic improvements during the initial permitting. They have committed to implementing the only mitigation that was not included in the previously approved plans.
- ~~The petitioner should revise the site plan and conditional note(s) to commit to reconstructing the ramps at the new signal to meet current standards. The North East corner would need two ramps, the North West corner ramp needs to be reconstructed.~~



- The petitioner should revise the site plan and conditional note(s) to commit to extending sidewalk along providence to Cloister Drive.

5. ~~The petitioner should revise the site plan to add a note specifying dedication and fee simple conveyance of all rights of way to the City before the site's first building certificate of occupancy is issued. CDOT requests right of way set at 2' behind back of sidewalk where feasible. The petitioner should update conditional note 4.c. to reflect verbiage in originally approved rezoning of "prior to the issuance of first CO". It does not appear that additional R/W will be required outside of what was in the originally approved rezoning.~~
6. ~~The petitioner should revise the site plan to add a note specifying all transportation improvements will be approved and constructed before the site's first building certificate of occupancy is issued. The petitioner may phase transportation improvements if said improvements and phasing are explicitly described in site plan notes.~~

## Advisory Information

The following are requirements of the developer that must be satisfied prior to driveway permit approval. We recommend that the petitioner reflect these on the rezoning plan as-appropriate.

1. The setback for this district is measured from the back of the existing or future curbline as determined by CDOT and Planning during the permitting process.
2. According to the City of Charlotte's Driveway Regulations, CDOT has the authority to regulate/approve all private street/driveway and public street connections to the right-of-way of a street under the regulatory jurisdiction of the City of Charlotte.
3. Adequate sight triangles must be reserved at the existing/proposed street entrance(s). Two 35' x 35' sight triangles (and two 10' x 70' sight triangles on North Carolina Department of Transportation on NCDOT maintained streets) are required for the entrance(s) to meet requirements. All proposed trees, berms, walls, fences, and/or identification signs must not interfere with sight distance at the entrance(s). Such items should be identified on the site plan.
4. The proposed driveway connection(s) to public streets will require a driveway permit(s) to be submitted to CDOT (and the North Carolina Department of Transportation on NCDOT maintained streets) for review and approval. The exact driveway location(s) and type/width of the driveway(s) will be determined by CDOT during the driveway permit process. The locations of the driveway(s) shown on the site plan are subject to change in order to align with driveway(s) on the opposite side of the street and comply with City Driveway Regulations and the City Tree Ordinance.
5. All proposed commercial driveway connections to a future public street will require a driveway permit to be submitted to CDOT for review and approval.
6. Any fence or wall constructed along or adjacent to any sidewalk or street right-of-way requires a certificate issued by CDOT.
7. A Right-of-Way Encroachment Agreement is required for the installation of any non-standard item(s) (irrigation systems, decorative concrete pavement, brick pavers, etc.) within a proposed/existing City maintained street right-of-way by a private individual, group, business, or homeowner's/business association. An encroachment agreement must be approved by CDOT prior to the construction/installation of the non-standard item(s). Contact CDOT for additional information concerning cost, submittal, and liability insurance coverage requirements.
