This Community Meeting Report is being filed with the Office of the City Clerk and the Charlotte Planning, Design and Development Department pursuant to the provisions of the City of Charlotte Zoning Ordinance.

PERSONS AND ORGANIZATIONS CONTACTED WITH DATE AND EXPLANATION OF HOW CONTACTED:

A representative of the Petitioner mailed a written notice of the date, time and location of the Community Meeting to the individuals and organizations set out on <u>Exhibit A-1</u> attached hereto by depositing such notice in the U.S. mail on May 3, 2019. A copy of the written notice is attached hereto as Exhibit A-2.

DATE, TIME AND LOCATION OF MEETING:

The Community Meeting was held on Wednesday, May 15, 2019 at 6:30 PM at Design Resource Group located at located at 2459 Wilkinson Boulevard, Suite 200, in Charlotte, North Carolina.

PERSONS IN ATTENDANCE AT MEETING (see attached copy of sign-in sheet):

The Community Meeting was attended by those individuals identified on the sign-in sheet attached hereto as <u>Exhibit B</u>. The Petitioner's representatives at the Community Meeting were Clay McCullough of the Petitioner, Nick Bushon of Design Resource Group and John Carmichael of Robinson Bradshaw & Hinson, P.A.

SUMMARY OF ISSUES DISCUSSED:

Since only Council Member Mayfield attended the Community Meeting, the Community Meeting was very informal.

John Carmichael stated that the site subject to the this Rezoning Petition contains approximately 2.65 acres and is located at the intersection of Bryant Park Drive and Isom Street between Suttle Avenue and West Morehead Street. The site is adjacent to an approved townhome community that he believes is under construction, and is behind a new apartment community to be located on Wilkinson Boulevard.

John Carmichael stated that the Petitioner is requesting that the site be rezoned from the O-1 and I-2 zoning districts to the MUDD-O zoning district to accommodate a residential community on the site that could contain up to 56 townhome units.

Nick Bushon then discussed the Petitioner's site plan in more detail.

Council Member Mayfield asked about access to the site, and a discussion ensued regarding access to the site. John Carmichael stated that the site would be accessed from Suttle Avenue, which you can access from Wilkinson Boulevard and West Morehead Street, and Bryant Park Drive.

Clay McCullough briefly discussed the proposed townhome units.

John Carmichael thanked Council Member Mayfield for attending the meeting, and the meeting was adjourned.
