#### COMMUNITY MEETING REPORT

This Community Meeting Report is being filed with the Office of the City Clark and the Charlotte-Mecklenburg Planning Commission pursuant to the provisions of the City of charlotte Zoning Ordinance.

#### PERSONS AND ORGANIZATIONS CONTACTED WITH DATE AND EXPLANING HOW CONTACTED:

A representative of the Petitioner mailed a written notice of the date, time and location of the Community Meeting to the individuals and organizations set out on Exhibit A attached hereto by depositing such notice in the U.S. mail on July 12, 2019. A copy of the written notice is attached to as Exhibit B.

#### **DATE, TIME AND LOCATION OF MEETING:**

The Community Meting was held on July 23, 2019 at 6 p.m. at Beatties Ford Rd Library – 2412 Beatties Ford Rd, Charlotte, NC.

### PERSONS IN ATTENDANCE AT MEETING (see attached copy of sign-in sheet):

The Community Meeting was attended by those individuals identified on the sign-in sheet attached hereto as <u>Exhibit C</u>. The Petitioner was represented at the Community Meeting by Greg Hardee, Gardine Wilson and Fred Atiemo.

#### **SUMMARY OF PRESENTATION/DISCUSSION:**

The Petitioner's agent, Greg Hardee, welcomed the attendees and introduced the Petitioner's team. Greg Hardee indicated that the Petitioner proposed to rezone an approximately 1.25 acreage site (the "Site") located at 3221 & 3231 Auten Avenue, Charlotte, NC from the B-2 & R-4 zoning districts to NS zoning district. Greg Hardee explained the rezoning process in general and stated that the purpose of the meeting was to discuss the rezoning request and the conditional site plan and respond to questions and concerns from nearby residents and property owners.

Greg Hardee provided background information about the experience of the representatives and what the operation of the facility would be, reestablish the iconic African American restaurant (Coffee Cup). Greg Hardee, Fred Atiemo and Gardine Wilson at different times used the elevations and renderings to explain the facility's design concepts and operations.

A question was raised as to whether the Petitioner would ensure that there is a buffer at the end of the property line to which Fred Atiemo answered that the Petitioner will ensure that it meets and even exceeds the development required buffer.

Another question came up about vehicles that pack on the side of the grocery store at the Auten Avenue to which Fred Atiemo responded that the grocery store has been using that space for parking for many years so there is the possibility that it has been grandfathered.

Another attendee inquired about the rough surface of Auten road leading to the housing units. Fred Atiemo responded that the paving of the road is something that the neighborhood may want to discuss with the city.

There was also mention of how fast vehicles merge onto the street between the newly constructed 7-11 store and the Family Dollar store. Gardine Wilson mentioned that perhaps that would be something for the neighborhood to discuss with the Family Dollar store and/or the city since it has no bearing on Petitioner's property.

At the end of the meeting, the attendees expressed their interest in seeing a family-style restaurant coming to the area. There was no opposition to the proposed rezoning and the project.
