COMMUNITY MEETING REPORT Petitioner: Culp Road Materials, LLC

Rezoning Petition No. 2019-90

This Community Meeting Report is being filed with the Office of the City Clerk and the Charlotte-Mecklenburg Planning Commission pursuant to the provisions of the City of Charlotte Zoning Ordinance.

PERSONS AND ORGANIZATIONS CONTACTED WITH DATE AND EXPLANATION OF HOW CONTACTED:

A representative of the Petitioner mailed a written notice of the date, time and location of the Community Meeting to the individuals and organizations set out on Exhibit A attached hereto by depositing such notice in the U.S. mail on August 22, 2019. A copy of the written notice is attached hereto as Exhibit B.

DATE, TIME AND LOCATION OF MEETING:

The Community Meeting was held on Wednesday, September 4, 2019 at 6:30 PM at Stratford Richardson YMCA, 1946 West Boulevard, Charlotte, NC 28208.

PERSONS IN ATTENDANCE AT MEETING (see attached copy of sign-in sheet):

The Community Meeting was attended by those individuals identified on the sign-in sheet attached hereto as Exhibit C. The Petitioner was represented at the Community Meeting by R. Susanne Todd, Attorney with Johnston, Allison & Hord, P.A.

SUMMARY OF PRESENTATIO N/DISCUSSION:

Attorney Susanne Todd welcomed the sole meeting attendee, Council Member Lawana Mayfield, and introduced Mr. Kojo Sapon, owner of Culp Road Materials, LLC and president of Express Logistics Services, a dump truck hauling service. Ms. Todd stated that the Petitioner proposed to rezone an approximately 35 acre site (the "Site") located at 8329 Old Dowd Road in Charlotte, North Carolina and including Mecklenburg County Parcel #s 11312255 & 11312256 from R-3 zoning district to I-2 (CD) zoning district to allow for contractor offices and storage, along with specific other uses and accessory uses allowed by right or under prescribed conditions in I-2 zoning district.

Ms. Todd provided attendees with a copy of the current Site Plan explaining that it was subject to change based on planning staff comments received the previous day. An aerial was provided to show surrounding uses. The Site has some challenges due to topography and streams. Petitioner plans to fill and grade the Site as allowed by applicable regulations and use it for his offices and storage now but redevelop the Site in the future based on market demands around the airport.

Attendees were provided an agenda with the following dates: October 21, 2019: Earliest date for Public Hearing November 5, 2019: Zoning Committee Meeting November 18, 2019: City Council Decision.

The Site is slightly outside of City limits, however Council Member Lawana Mayfield attended the Community Meeting since her district is closest to the Site. Ms. Mayfield expressed concern that the

lack of other attendees might be because the Community Meeting was being held on the other side of Billy Graham Blvd from Site. The area surrounding the Site is largely industrial or vacant land, with an adjacent mobile home park. Petitioner's agent agreed to follow up with any Home Owners Associations listed by the City in the area. Ms. Mayfield also questioned the five year vested rights request citing the fact that this area is changing so quickly.




