Meeting Recap October 20, 2011

Noise Ordinance Overview:

- Covers the use of Outdoor Amplification and Music at Commercial Establishments
- Decibel levels range of 60 to 85 decibels, based on the time of day and the day of the week.
- Decibels levels are measured at the property line of the property in which the sound is being generated.



Meeting Recap October 20, 2011

Recommendations: Definitions for: 1. Social Entertainmer 2. Restaurants 3. Restaurant with Social Entertainment closing after midnight 4. Nightclubs, Bars and Loundes



Meeting Recap October 20, 2011

PRESCRIBED CONDITIONS Restaurant with Social Entertainment, closing after midnight and Nightclubs:

- 400 separation required from social entertainment within an enclosed building, or from where social entertainment is located outside of building.
- If a major thoroughfare, railroad, or greenway is adjacent to a restaurant, then the minimum separation distance on that adjacent side(s) may be reduced to a minimum of 300 feet.



1. Separation Requirement

- a. 400 Too Excessive reduce to 200', 100', 50' or 25'
- Keep separation as is people want a safe neighborhood
- c. Negative impacts late night and alcohol

2. Social Entertainment

- a. Allow a restaurant to remain open after midnight.
- a. Include outdoor entertainment at 400'



FEEDBACK RECEIVED

3. Restaurant

- a. Giving restaurants more options is an issue for residences
- b. Allow noise up to midnight
- c. Stay inside with noise and stay open longer
- d. Use of promoters if using on regular basis – classify as a nightclub



4. Noise

- a. Change closing hours from midnight to 11:00 pm (some against) to be more in line with noise ordinance
- b. Decrease decibel level lower than the current noise ordinance after midnight
- c. Use fines as deterrent to observe noise level









